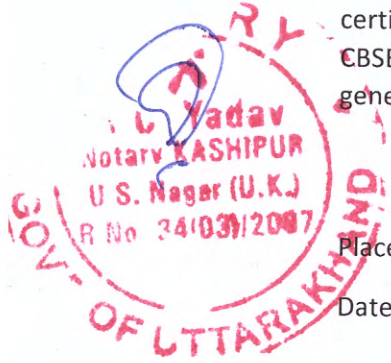
#### AFFIDAVIT
